## The Infant Feeding Academy: 12 Monthly Instalments Terms and Conditions

These Terms and Conditions govern the use of the 12 monthly instalments option for products purchased from The Infant Feeding Academy. By opting to pay by 12 monthly instalments, you agree to be bound by the terms outlined below.

## 1. General Agreement

The Infant Feeding Academy ("we," "our," or "us") offers a 12 monthly instalments option for eligible products purchased through our website or other sales platforms. By opting to pay by 12 monthly instalments, you ("you" or "customer") agree to make monthly payments as set forth in this agreement.

#### 2. Product and Instalments

- 2.1 The product(s) purchased with the 12 monthly instalments option are clearly outlined in the transaction details and will be delivered as per our standard terms and conditions, found <a href="https://example.com/html/>here.">here.</a>
- 2.2 This option consists of 12 equal monthly instalments, each due on the same calendar date each month, starting from the date of the first payment.
- 2.3 A certificate of qualification will be issued upon successful completion of the course, and The Infant Feeding Academy reserves the right to delay it's issuing until full payment has been made.

#### 3. Payment Method

- 3.1 Payments will be processed through the payment method you provide at checkout.
- 3.2 You are responsible for ensuring that your payment method is valid and has sufficient funds to cover each monthly payment.
- 3.3 If your payment method is declined for any reason, you will be notified and must update your payment details within 7 days to avoid disruption to your Program.

# 4. Payment Schedule

- 4.1 The first payment will be charged immediately upon enrolment in the 12 monthly instalments. Subsequent payments will be charged on the same day of each subsequent month.
- 4.2 If you need to make adjustments to the payment schedule or date, you must contact The Infant Feeding Academy in writing at least 5 business days before the next scheduled payment.

### 5. Late Payments

- 5.1 If you fail to complete your instalment payments as agreed after successfully qualifying, The Infant Feeding Academy reserves the right to revoke your certificate/qualification and any associated recognition, with any payments made to date be retained by The Infant Feeding Academy.
- 5.2 Prior to completion, non-payment at any point during the 12 monthly instalments period will result in immediate removal from the course. The Infant Feeding Academy will retain any payments made up until that date.
- 5.3 If you have agreed to pay by 12 monthly instalments directly with The Infant Feeding Academy prior to the course commencing, any payments not made in accordance with this agreement will result in immediate removal from the program, with any payments made to date retained by The Infant Feeding Academy.
- 5.4 If you withdraw from the program for any reason, or are removed for non-payment, you will remain responsible for the full payment as agreed when enrolling in the Program.

### 6. Modifications to Terms

The Infant Feeding Academy reserves the right to modify these terms at any time. Any changes will be communicated to you, and you will have the option to accept the revised terms or continue with your existing terms.

# 7. Dispute Resolution

- 7.1 In the event of a dispute, you agree to attempt to resolve the matter informally by contacting The Infant Feeding Academy in writing.
- 7.2 If the dispute cannot be resolved through informal means, you agree to submit to mediation or arbitration in accordance with applicable laws.
